### ANNOUNCEMENT OF PROPOSED CHANGES TO WATER SERVICE RATE TARIFFS FILED WITH THE PUC

DATE: **July 11, 2024**

**AVION WATER COMPANY, INC.**, submitted a general rate filing to the Commission on **JUNE 28, 2024**. We are seeking to increase our annual revenues by **\$1,818,895** above the **\$11,606,538** we collected in **2023** (*insert test year*). The purpose of this announcement is to provide you with general information regarding the proposed rates and the effect the filing may have on you.

We anticipate the increase will change the average monthly water service rates as follows:
